 - o 3 water pressure zones in Montclair due to elevation changes
 - o During summer we get more water from our wells
 - 2 of 3 wells have carbon filters to reduce regulated PFAS to undetectable levels.
 3rd well will have carbon filters installed this year.
 - Public should report the smell of sewage to Gary Obszarny at <u>GObszarny@MontclairNJUSA.org</u> or by calling the Water Bureau and Sewer Utility
 - o For water billing questions call:973-509-4924 / 4925
 - For sewer billing questions call: 973-509-4977, 4921
 - o Leaky sanitary sewer pipes are being fixed each year.
 - Water lines are being upgraded to avoid root intrusions.
